Discipline Policy

Verbal Warning

The purpose of the verbal warning is to notify TDBF Prep Star members of behavior that will not be tolerated by TDBF. Repeated violations will result in a written warning.

Written Warning

The purpose of the written warning is to notify TDBF member of the behavior that will not be tolerated by TDBF and record the violation in TDBF member's program file. This disciplinary caution the repetition of the behavior in question may result in a more severe sanction. The Program Coach, Staff Member or Program Director has the discretion to issue a suspension sanction upon the first warning if the delineated clearly in TDBF Code of Excellence. Written Warnings are written by Program Coaches and signed by member in violation. By signing the incident report, TDBF member disagrees with the incident report, he/she has the right to submit written documentation appealing the incident.

Suspension

For certain severe violations of TDBF Code of Conduct, TDBF members shall be suspended from the program. In addition, members will be placed on probation following their suspension for seven days.

Dismissal

The Douglas Brothers Foundation members will be dismissed from TDBF for multiple or serious violations of the Code of Conduct.
